AGM

Treasurer – John Roberts

Prepares for the correct procedures for AGM and lodgement of forms with PSPL and CAV after this (Lyn Elsbury is an excellent Membership Officer who handles some of my “official” membership duties)

Outings, Activities and Tours Officer – Kathy McLennan

Investigate and propose suitable outings and activities to the Management Committee.

Club and Committee members can also propose activities to the Tours Officer and many activities e.g. GPAC, DDM and Car Trial are a team effort.

The position is fun and rewarding.

Membership Officer Role – Lyn Elsbury

The Membership Officer is responsible for maintaining up-to-date membership records, management of membership applications and assisting with membership retention and growth.

The membership records are on a database, and individual files are also kept enabling yearly emails to be sent out for updates.

Meeting Attendances are also taken by the Officer and a Club assistant for each meeting.

The assistant is also responsible for Welfare.

Guest Speaker Officer – Liz Gielewski

Approach club members to speak at meetings, or arrange other activities for that time in the meeting
